

2022 Moody Splash Pad Pavilion Rental Rates & Guidelines



Operating Hours Pavilion Rental Fee:

Pavilion rentals require a 2hr minimum and every one over the age of 2yrs must pay admission for the Splash Pad which is NOT included in the Pavilion rental fee. Parties over 35 guests require an additional pavilion reserved to accommodate. If you have over 35 and do not rent an additional pavilion, your security deposit will be forfeited.

Rental hours: 9:30 AM to 5:00 PM (Tuesday-Saturday)

Rental hours: 1:30 PM to 5:00 PM (Sunday)

Security Deposit: \$50.00

Tuesday – Sunday

Moody Resident: \$30.00 per hour Non-resident: \$60.00 per hour

Splash Pad Party Perk Admission: \$1.50 per person / Birthday child & 2 parents are free.

Exclusive After Hours Rental Fee:

Rental hours: 5:30 to 7:30 PM (Tuesday-Sunday)

Security Deposit: \$100.00 Moody Resident: \$325.00 Non-resident: \$425.00

Private party rentals are only available outside of our operational hours. The rental rate includes exclusive use of the Splash Pad, Pavilions and Splash Pad Admission fee.

2022 Moody Splash Pad Pavilion Rental Rates & Guidelines

Guidelines

Alcohol:

Alcoholic or intoxicating substances of any kind are prohibited. The use of such substances will result in immediate expulsion and forfeiture of any and all fees. Future applications for pavilion rental used by individuals using such substances or groups associated with individuals will not be considered.

Animals:

Pets are not permitted inside the fenced in area. Anyone having a pet outside the fenced area is expected to clean up after their pet.

Attire:

Swimsuits and/or appropriate attire must be worn at all times. Cut-offs, gym, and dress shorts are not permitted. Children not toilet trained must wear a swim diaper. Regular disposable or cloth diapers will not be allowed.

Bands/DJ's/Music:

Not allowed

Cancellations:

Cancellations must be submitted at least one (1) month in advance or deposit & pavilion rental fees are forfeited. Within (1) month we are able to reschedule your rental during the current Splash Pad Season. Also, in the event that your rental is canceled due to weather, we will reschedule your rental for another day during the current season. We are not able to give refunds due to weather.

Cleaning/Garbage:

The Client is responsible for cleaning up the Pavilion after the event & leave the Pavilion in the same way it was found upon arrival. **The Client is responsible for the removal of all garbage, boxes, etc.** Leaving trash inside the Pavilion is not allowed, an onsite dumpster is located behind the Civic Center to dispose of all trash. You will forfeit your Security Deposit if the Pavilion is not left as clean as it was when you arrived.

Conduct:

- Persons must conduct themselves in a courteous, safe, and family-oriented manner. The use of profanity or abusive language, symbols or gestures may result in removal from the Splash Pad. Refunds will not be issued and if using a pavilion—deposit and rental fees will be forfeited.
- Running and horseplay are not permitted anywhere inside the fenced area.
- Bicycles, scooters, and skateboards are not permitted. Amplified music is not permitted.
- Children under the age of 16 must be accompanied by an adult. Adult needs to remain inside the Splash Pad fencing while the child is inside.
- As the Renter it's your responsibility to make sure your guest abides by the rules of this agreement.
- Applicant/Renter must be at least 21 years of age, remain on premises inside the Splash Pad fencing at all times during rental period.

Damages:

Renter assumes full responsibility for any and all damages to the physical premises and property of Moody Splash Pad. Further, the Renter assumes responsibility for all personal injuries or other damages caused by the renter, renter's guests, renter's agents, renter's representatives, renter's employees and/or renter's independent contractor(s).

Decorations:

Decorations & activities are allowed under the pavilion you have rented, not outside of your rented pavilion. However, glitter, confetti or tinsel is not allowed.

2022 Moody Splash Pad Pavilion Rental Rates & Guidelines

Food & Beverage:

Glass containers are prohibited anywhere on the premises. Food and drinks are not allowed on Splash Pad area and MUST remain under the rented pavilion. Grills are not permitted. Personal coolers are only allowed to transport your party food to your rented pavilion only. **We are not able to store items in the Splash Pad office for your party, including cake & ice cream. Please do not ask the Attendants working.**

Hours:

Hours of Operations: Tuesday through Saturday 9am-6pm & Sunday 1pm-5pm. The Splash Pad will be closed on Mondays for maintenance, unless it is a holiday in which it will close the following Tuesday. Pavilion Rental Times are Tuesday through Saturday 9:30am-5:00pm & Sunday 1:30pm-5:00pm.

Illness:

Persons with diarrhea, nausea, skin, eye, respiratory infections, open lesions or wounds will not be permitted on the Splash Pad.

Insufficient Funds:

MSP will charge a \$40.00 fee for check returned with non-sufficient funds and immediate cash payment will be due to maintain reservation

Loss/Theft:

The Splash Pad does not provide security for valuables or personal property. Attendees are solely responsible for safeguarding any valuables, and the Splash Pad shall not be responsible for any loss whatsoever.

Maintenance:

In order to keep our guests safe and all areas clean, the Splash Pad may close due to unforeseen circumstances such as maintenance, mechanical or operational needs. The potential renter is reminded that this is a publicly owned facility location on city property. Only the pavilion is being rented & it's not guaranteed that the Splash Pad will be operational during the time of rental due to unforeseen maintenance. Covering water fixtures or drains is not allowed. Water is chlorinated and re-circulated through a filtration system.

Minors:

Minors are not permitted to run and/or behave in a disruptive or dangerous manner while on the premises of the Facility. Further, minors are required to be under the supervision of a responsible adult at all times. This includes you may not drop off your minors, sit in the car while they are inside the pad or on the picnic tables while they are inside the pad.

Occupancy:

Pavilion Rental Capacity is 35 guests, if you go over that amount you will need to book two pavilions to accommodate. If you do not book another pavilion, you will forfeit your security deposit. The maximum number of guests allowed on the Splash Pad is 150. Church or School groups **MUST** be scheduled through the Moody Civic Center Manager by calling 205-640-8632.

Parking:

The Splash Pad has parking spaces for use at no charge, for guest parking only. We ask you place your trash in the trash cans vs leaving on the ground.

Portable Structures:

Portable structures such as, but not limited to, gazebos, canopies, umbrellas or chairs are not permitted.

Rain Checks:

In order to keep our guests safe and all areas clean, the Splash Pad may close due to unforeseen circumstances in the event of threatening or inclement weather. In the event of closure, rain checks may be issued unless it is during the last hour of operation. This offer is valid for the current season only. No refunds will be given.

2022 Moody Splash Pad Pavilion Rental Rates & Guidelines

Rental Time:

Your rental time includes your set-up, tear-down & clean-up. Pavilion rentals require a 2hr minimum. You are reserving your pavilion not the other pavilions around you. Please use only your reserved pavilion. Arriving before your scheduled rental time, leaving after your scheduled rental time or using other pavilions will result in forfeiting your Security Deposit.

Refunds:

In the event the Splash Pad does not open for the day, due to weather or maintenance, a refund will be given. However, if the Splash Pad is opened and unforeseen weather approaches during your rental time, refunds will not be given. We will reschedule your rental or depending on the time, we may be able to extend your rental once the inclement weather passes.

Security Deposit:

\$50 or \$100 Security Deposit for Pavilion Rental is due at the time of making the reservation and can be paid via cash, check, or credit card. Security Deposit amount does not go towards the Pavilion Fee or the Entry into the Splash Pad. Security Deposit will be forfeited if your pavilion and surroundings are not left in a clean and in an orderly condition. Trash and litter must be placed in appropriate containers. Deposit will be forfeited for disorderly conduct and for not following the rules of this agreement. Deposit will be mailed back in the form of a check within 7-10 business days from the City of Moody.

Smoking:

Smoking, including Vape, and tobacco products are not permitted inside the fence or within 50 feet of the exterior of the facility.

Temporary Additions/Vendors:

Any temporary additions to the inside or outside areas of the Splash Pad such as concession stands, mobile food or drink, ice cream/snow cone vehicles, tents, pony rides, temporary structures, or any other type of outside vendors will not be permitted due to damage that may be incurred to the property. Any outside vendor will be asked to leave the premises.

Toys:

Athletic equipment, balls, bats, beach balls, noodles, etc. are not allowed on the Splash Pad. This includes small toys with parts that can break off.

The City of Moody reserves the right to remove participants for violating any of the rules or engaging in illegal, disruptive, destructive, or inappropriate behavior, without refund. By signing below, I agree that I have read the rules, regulations and guidelines pertaining to the rental and agree to uphold them. I, the undersigned individual, on behalf of the above-named person or organization, agrees to be entirely responsible for any and all loses, damages or other injuries to property owned by the City of Moody while my guests are on the property and will be responsible for the event concluding at the time agreed upon. By signing below, I agree to indemnify and hold harmless the City of Moody and its employees, agents or Representatives from any and all claims arising from any accident, injury or damage whatsoever, however caused to any person or property arising of or connected with the renter's occupancy of the City of Moody Splash pad property. I do hereby fully and forever release and discharge the City of Moody, its owners, employees and agents from any and all unknown, anticipated or unanticipated resulting from or arising out of my use or intended use of the City of Splash Pad facilities and equipment. This release is also binding not only to myself, but also upon my heirs and legal representatives. The City of Moody reserves the right to reject a facility reservation at any time if it believes the event or activity will interfere with other existing or planned activities. The City of Moody is the final authority concerning operating policies and procedures for all city owned facilities. The Moody Civic Center management has the management responsibility for public use of these facilities.
