Minimum age a child can attend the center without an adult over the age of 18yrs is 15yrs. Children 14yrs and under must be accompanied by an adult over the age of 18yrs at all times. Terms:

Adult:

A person 18 years of age or older.

Additional Family:

Once Family Membership is purchased each additional dependent child under the age of 18, unless child is a verifiable college student through age 25.

Family:

Exclusively for the head of household, his or her spouse & 2 dependent children under the age of 18, unless child is a verifiable college student through age 25.

Military:

10% off membership prices with your military ID.

Senior:

A person 60 years of age or older.

Student:

A person 25 years of age or younger who is a full time student.
